(ख) प्रारम्भ में आप दो वर्षों की अवधि के लिए परीक्षा पर रहेंगे, जो कि केवल असाधारण कारणों पर एक वर्ष की अवधि से अधिक के लिए नहीं बढ़ाया जा सकता है। परीक्षा काल में नियुक्ति प्राधिकारी के अनुसार यदि आप किसी भी कारणवश आरक्षक महिला (सामान्य ड्यूटी) के रूप में बल का एक कुशल सदस्य होने की संभावना नहीं रखते हैं तो सक्षम अधिकारी द्वारा किसी भी समय बिना कोई कारण बताए आपकी सेवाएं समाप्त की जा सकती हैं।

Initially, you will be on probation for a period of two years, which may not be extended for more than a duration of one year on exceptional reasons only. During the period of probation, if the appointing authority considers that you are not likely to become an efficient member of the Force due to any reason, your service can be terminated without assigning any reason or without any advance notice.
