All the lecturers must fulfill the required conditions as laid down by the UGC for obtaining next Higher scale under UGC scheme in due time, other-wise they will be not allowed the above mentioned higher scale during their service period.

As such necessary proposal for formal approval of appointment of all teaching and non-teaching staff as shown in the enclosed statement should enveriable be submitted to this Directorate at the earliest along with the undermention documents.


